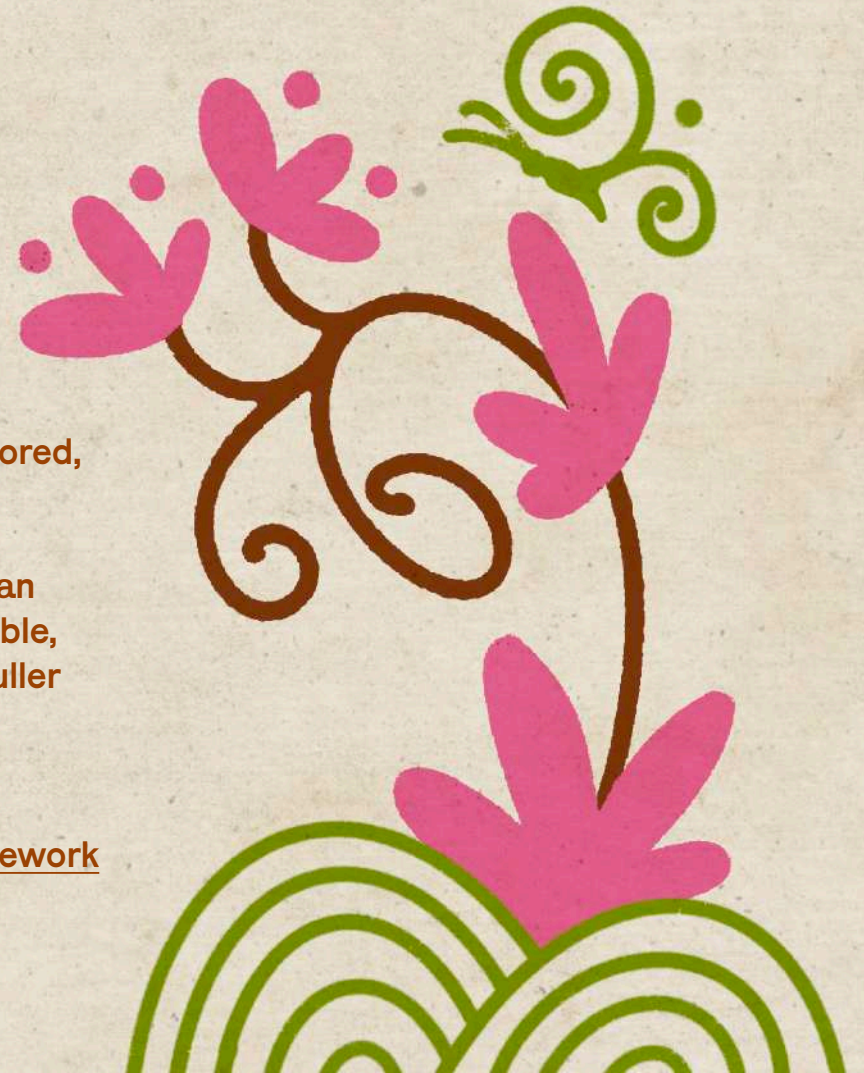
HOW TO GO THROUGH THIS DOCUMENT?

Towards equity, sustainability and justice

The earth, the womb of all life, is in trouble. Humanity, ridden with its own crises of inequality and exploitation, has mistreated its only home to the extent that life as we know it is itself imperiled. The coronavirus pandemic period (2020-22), which visiblized the cracks in the systems of the world, was a glaring symptom of the interconnected crises engulfing us. Do we have the wisdom and foresight to save ourselves and the diversity of life on the planet?

Can we take the urgent, widespread, and deep-rooted actions needed for this? A world that is built on respect, compassion, love, responsibility, freedom, diversity, and humility...not only in the relations among humans but also between humans and the rest of nature... surely we can not only dream this but also forge paths towards it?

This would entail a collective search for pathways and visions that are real alternatives to today's dominant economic, social and political system, taking us towards equity, justice, and ecological sustainability. How can such pathways and visions build on an existing heritage of ideas, values, worldviews, and cultures, and on past or new grassroots practices? How can they help meet the fundamental needs and aspirations of all, without exploiting the earth or privileging some at the expense of others? This note lays out some ideas, and is offered as one means to stimulate dialogue and visioning.

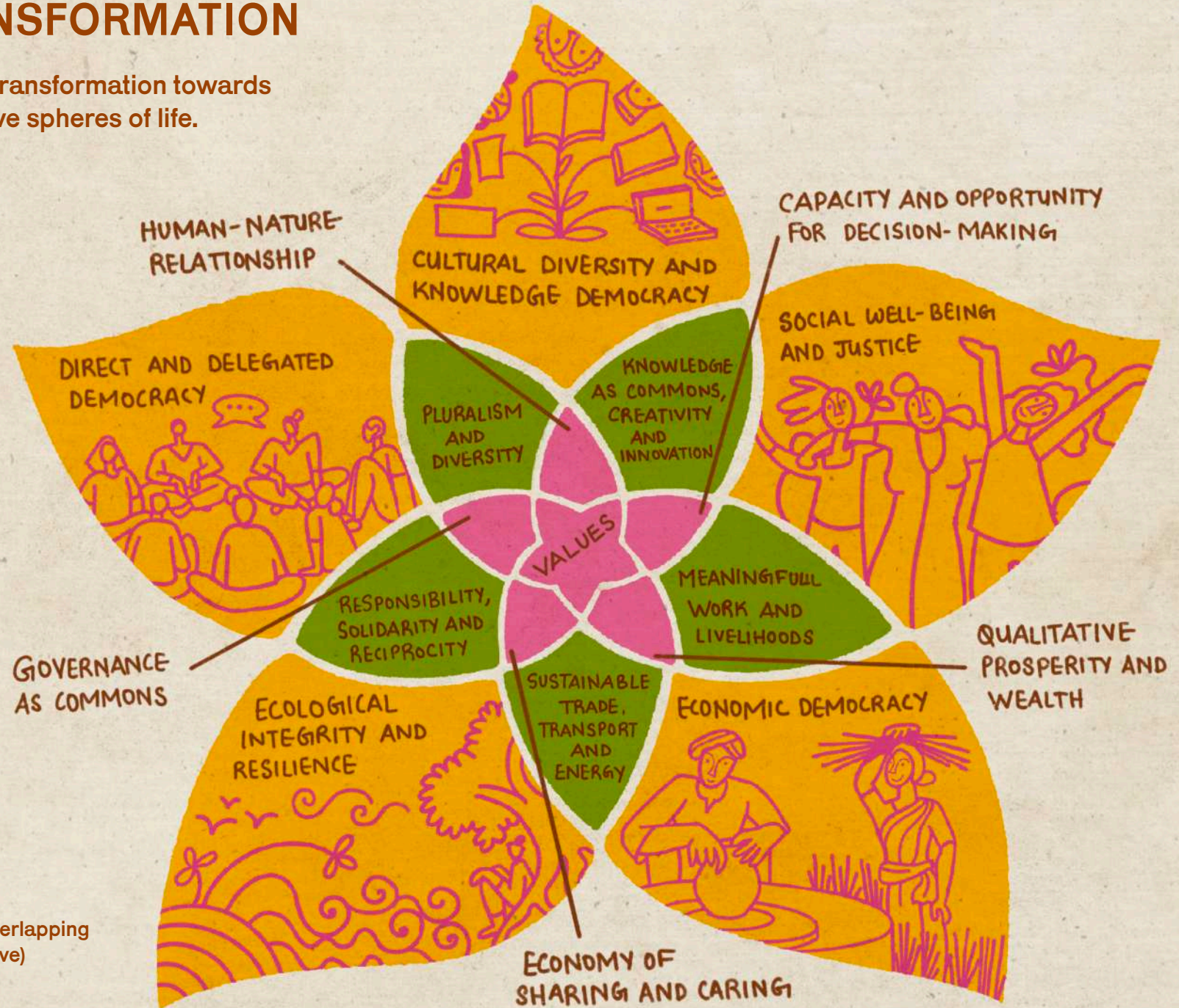

What is an Alternative?



Many or most current initiatives may not fulfill all the elements of the aforementioned five spheres. As a rough thumb-rule, perhaps we can consider something an alternative if it addresses at least two of the above spheres (i.e. is actually helping to achieve them, or is explicitly or implicitly oriented towards them), and does not violate but rather is open to and considers adopting the other spheres.

It is important to stress that this is not a judgemental or moralistic process of exclusion, but a practical one to enable some kind of distinctions for the purpose of collaboration, visioning, and dialogue. One outcome of the Vikalp Sangam process, based on this Framework note, is the Alternatives Transformation Format, a tool to help initiatives and organisations to self- assess how holistic and integrated (or conversely, inconsistent and fragmented) their actions and transformations are, and where they may want to make changes.

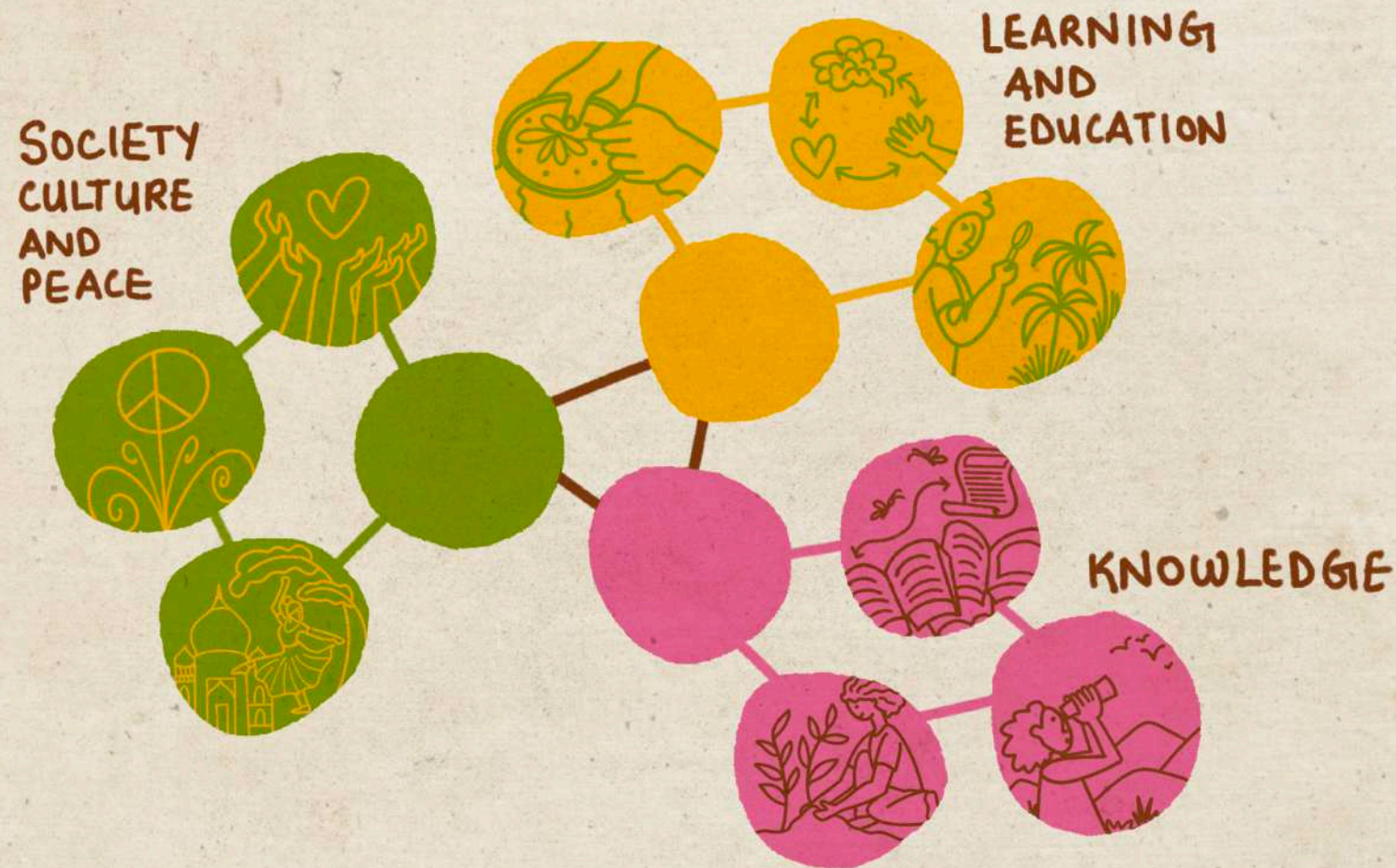
We note that both the above spheres, and the principles/values described below, are subject to differences of scale (local to global, personal to community and species level, etc) and time (short and long-term, and even the different perceptions of time, linear, circular, spiral).

SOCIETY, CULTURE AND PEACE

- Safeguard and revive arts, crafts, languages, and cultural diversity; nurture ecological and social harmony.
- Remove inequalities (caste, class, gender, ethnicity, literacy, race, religion, location) while fostering dignity, inclusion, and justice.
- Promote dialogue, ethical living, and tolerance; encourage approaches rooted in equity and shared humanity.

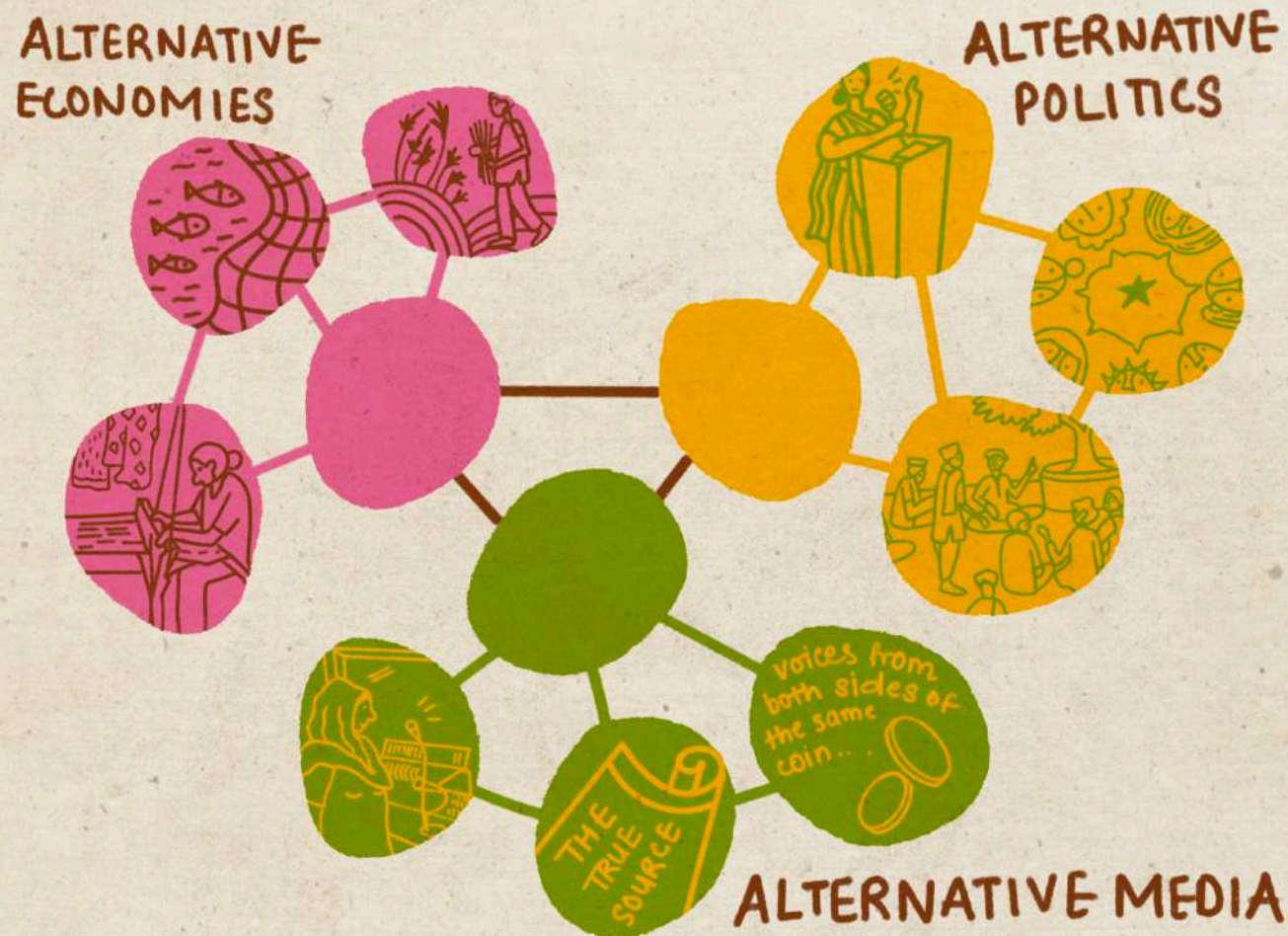
LEARNING AND EDUCATION

- Create learning spaces connecting people with nature, communities, inner awareness, and humanity.
- Blend formal and informal, traditional and modern education to nurture holistic growth and critical thinking.
- Ensure public accountability, inclusive teaching methods, and education that fosters joy, creativity and collaboration.

KNOWLEDGE

- Treat knowledge as a shared commons, enabling exchange between diverse traditions and disciplines.
- Share knowledge through respectful, inspiring methods such as storytelling, oral traditions, and modern media.
- Integrate different ways of knowing to advance equity, sustainability, and creativity.

ALTERNATIVE ECONOMIES & TECHNOLOGIES

- Build localised, decentralised, democratically controlled economies supporting diverse livelihoods, cooperatives, and gift exchanges.
- Guide production, trade, and technology with ecological integrity, cultural respect, and well-being as alternatives to GDP growth.
- Focus on solutions addressing root social and political issues, centering justice and sustainability.

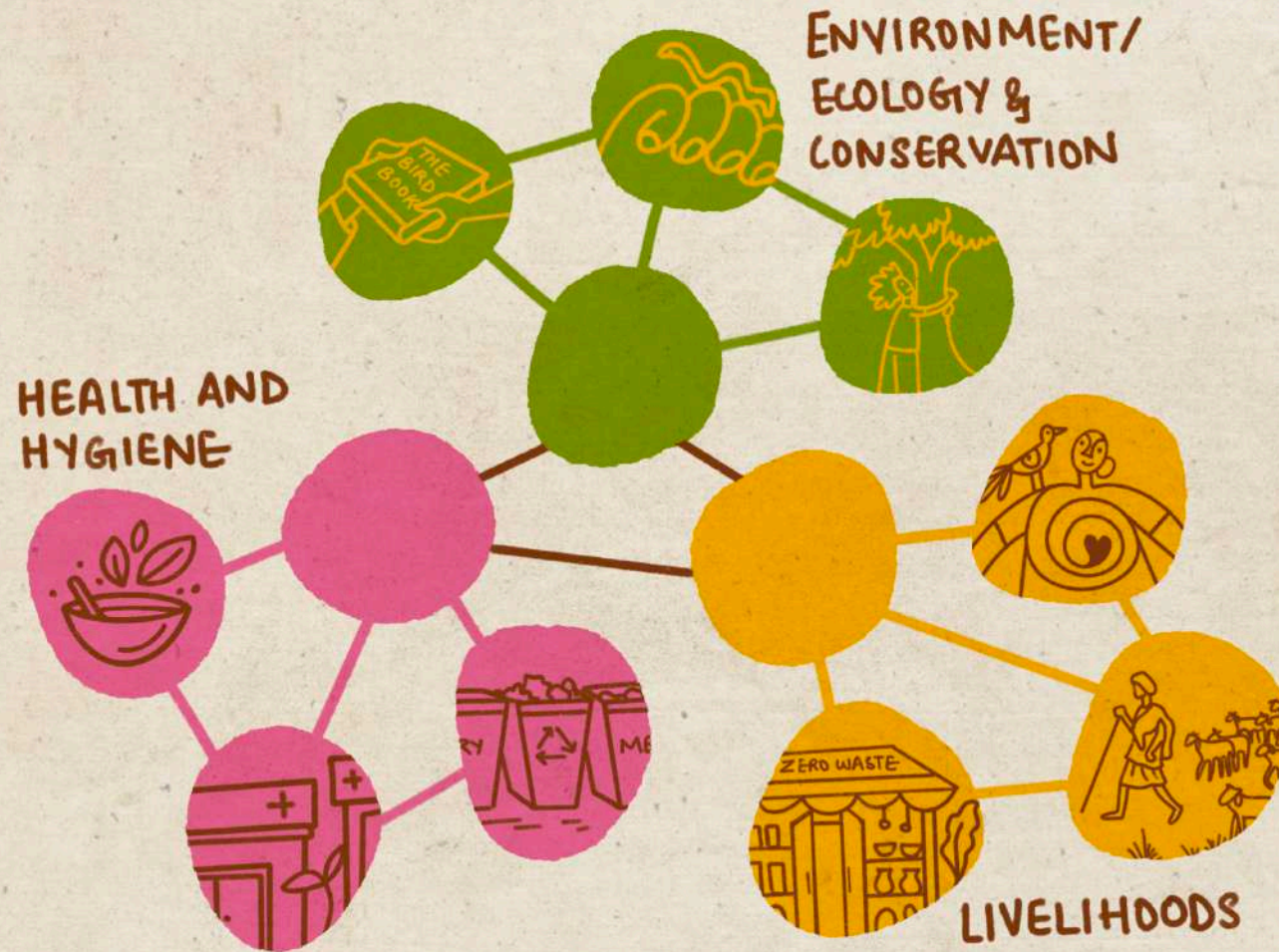
ALTERNATIVE POLITICS

- Create people-centred governance through direct participation, consensus, and fair power distribution.
- Link local democratic institutions across ecological and biocultural regions, rethinking boundaries for justice and sustainability.
- Strengthen transparency, accountability, and inclusive political spaces balancing individual and collective priorities.

KNOWLEDGE

- Treat knowledge as a shared commons, enabling exchange between diverse traditions and disciplines.
- Share knowledge through respectful, inspiring methods such as storytelling, oral traditions, and modern media.
- Integrate different ways of knowing to advance equity, sustainability, and creativity.

HEALTH AND HYGIENE

- Ensure provision of adequate nutrition, water, sanitation, clean environment, and safe mobility, thus preventing illnesses.
- Guarantee equitable healthcare through accountable public systems blending modern and traditional approaches.
- Encourage community-led health systems and shared responsibility for hygiene, ending caste-based division of work.

ENVIRONMENT, CONSERVATION, AND ECOLOGY

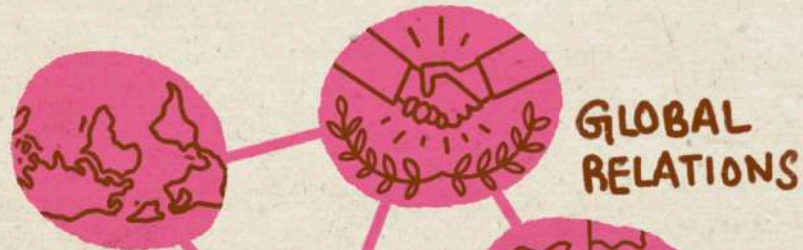
- Conserve land, water, and biodiversity using local and modern knowledge, linked to livelihoods and regeneration, and community decision-making.
- Reduce pollution and waste, deepen understanding of nature, and respect the rights of species and ecosystems.
- Choose restoration-focused solutions over superficial or symbolic measures.

LIVELIHOODS

- Support dignified, sustainable, fulfilling work, including eco-regenerative traditional occupations in farming, crafts, and fisheries.
- Promote manufacturing and services where people have equitable control and share fairly in revenues.
- Ensure collective access to land, water, forests, urban spaces, resources, technology, and knowledge.

SETTLEMENTS AND TRANSPORTATION

- Design rural-urban settlements that are sustainable, equitable, and fulfilling, with accessible housing and green architecture.
- Localise water and energy generation, protect biodiversity, and minimise waste using safe, toxin-free materials.
- Foster community-driven planning, equitable transport systems, and public spaces that prioritise people and non-motorised travel.

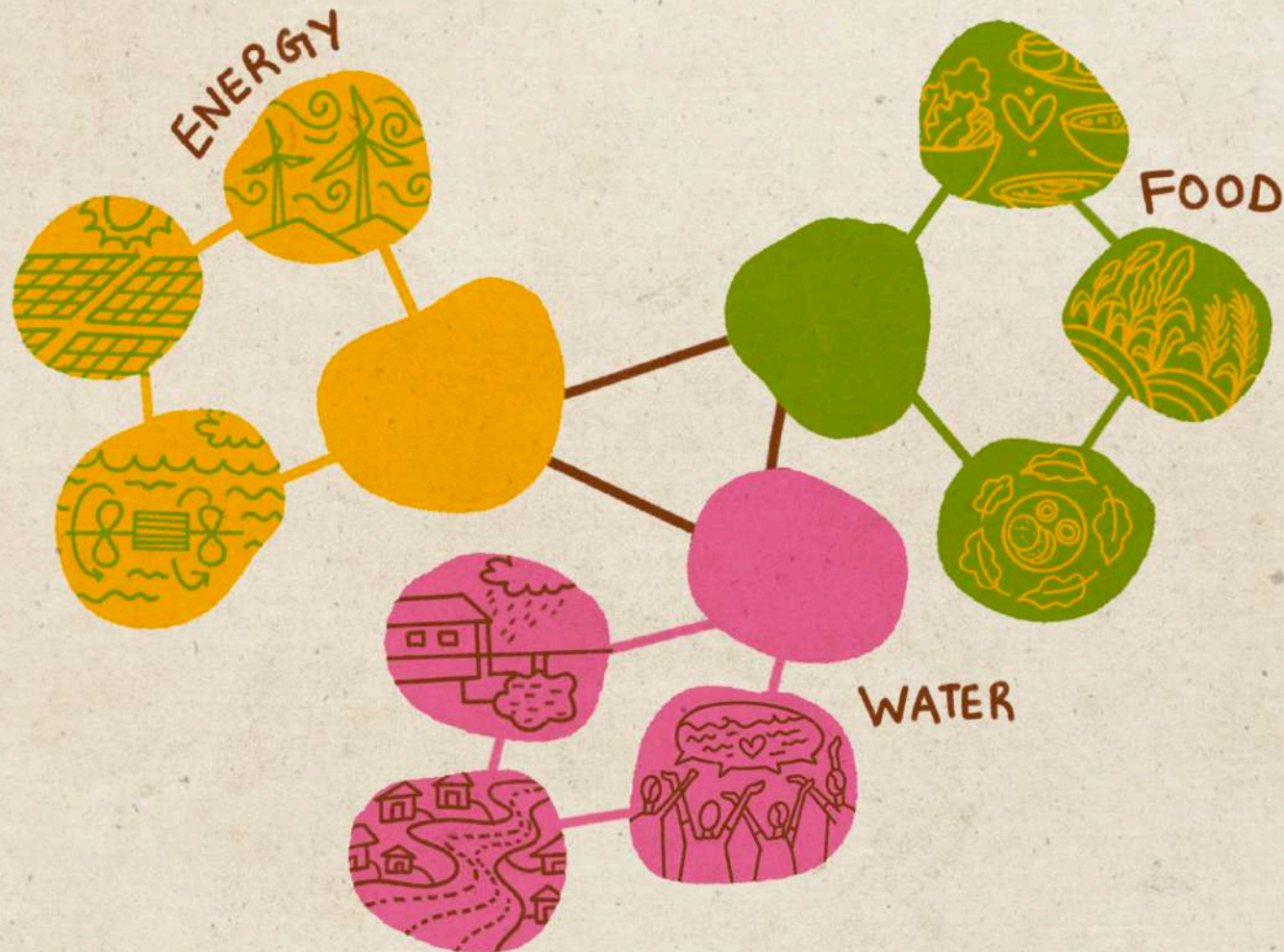
GLOBAL RELATIONS

- Promote diplomacy based on collective well-being, trust, and respect, addressing historical grievances.
- Support global disarmament, bans on harmful trade, and a multi-polar world without superiority claims.
- Encourage universal citizenship and greater roles for non-state collectives in global governance.

LAW AND CUSTOM

- Shape norms and laws through democratic, equitable processes grounded in dignity, diversity, and fairness.
- Address harm through empathy, redress, and rehabilitation rather than punishment.
- Promote values as shared daily practices, not just imposed rules.

ENERGY

- Advance community-run renewable energy with equitable access, replacing harmful large-scale sources.
- Support traditional and modern non-electric options, efficiency, and fair distribution of costs and benefits.
- Prioritise relevant, affordable technologies that uphold ecological and social well-being.

FOOD

- Ensure safe, nutritious, culturally diverse food, with communities in control of production and distribution.
- Promote organic farming, agro-biodiversity, and strong producer-consumer connections.
- Value slow, local, and traditional foods over unsustainable or elitist trends.

WATER

- Manage water sustainably, efficiently, and equitably, keeping it as a shared commons.
- Promote decentralised conservation of wetlands through democratic governance.
- Focus on community-governed, accessible water solutions for all.
